- ✦ **The Related/Unrelated PARA (Income Maintenance) RATE remains unchanged at \$162.00 per month**
- ✦ **The KINSHIP LEGAL GUARDIANSHIP rate remains unchanged at \$250.00 per month, with no clothing allowance, for those finalized before 7/1/2004 and for those children whose living arrangement meets the criteria in the DYFS Support Manual, Section III F DYFS Administrative Code.**
- ✦ **Effective 8/1/2005, the REDUCED Subsidy Adoption Rate for clients over 18 years old was no longer applied**

The rate is from **Table #8 (new as of January 2010)** if the step (level) is "00" ("A") through "03" ("D") and:

- The child's placement type is non-contracted resource family home care or relative care (licensed or unlicensed) or pending subsidy adoption *initiated any date*  
OR
- The child's placement type is kinship legal guardianship and the placement/finalization was initiated **on or after 1/1/2010**  
OR
- The child's placement type is final subsidy adoption and the placement/finalization was initiated **on or after 1/1/2010**

The rate is from **Table #7** if the step (level) is "00" ("A") through "03" ("D") and:

- The child's placement type is kinship legal guardianship and the placement/finalization was initiated **1/1/2009 – 12/31/2009**  
OR
  - The child's placement type is final subsidy adoption and the placement/finalization was initiated **1/1/2009 – 12/31/2009**
- 

The rate is from **Table #6** if the step (level) is "00" ("A") through "03" ("D") and:

- The child's placement type is kinship legal guardianship and the placement/finalization was initiated **1/1/2008-12/31/2008**  
OR
  - The child's placement type is final subsidy adoption and the placement/finalization was initiated **1/1/2008-12/31/2008**
- 

The rate is from **Table #5** if the step (level) is "00" ("A") through "03" ("D") and:

- The child's placement type is kinship legal guardianship and the placement/finalization was initiated **1/1/2007-12/31/2007**  
OR
  - The child's placement type is final subsidy adoption and the placement/finalization was initiated **1/1/2007-12/31/2007**
- 

The rate is from **Table #4** if the step (level) is "00" ("A") through "03" ("D") and:

- The child's placement type is kinship legal guardianship and the placement/finalization was initiated between **1/1/2006 and 12/31/2006**  
OR
  - The child's placement type is final subsidy adoption and the placement/finalization was initiated from **1/1/2006 through 12/31/2006**
- 

The rate is from **Table #3** if the step (level) is "00" ("A") through "03" ("D") and:

- The child's placement type is kinship legal guardianship and the placement/finalization was initiated between **1/1/2005 and 12/31/2005**  
OR
  - The child's placement type is final subsidy adoption and the placement/finalization was initiated from **1/1/2005 through 12/31/2005**
- 

The rate is from **Table #2** if the step (level) is "00" ("A") through "03" ("D") and:

- The child's placement type is kinship legal guardianship and the placement/finalization was initiated from **7/1/2004 through 12/31/2004**  
OR
  - The child's placement type is final subsidy adoption and the placement/finalization was initiated from **3/1/1999 through 12/31/2004**
- 

The rate is from **Table #1** if the step (level) is "00" ("A") through "03" ("D") and:

- The child's placement type is final subsidy adoption and the placement/finalization was initiated from **1/17/1984 through 2/28/1999**
- 

**For steps/levels other than "00" through "03":**

- The rates that are indicated in the "**Specialized Home Service Provider(SHSP)**" rate table are required based on the child's handicapping condition (medically fragile, asymptomatic HIV, symptomatic HIV) and the placement type is Specialized Home Service Provider(SHSP).
  - Any **non-standard rate** amount up to a limit specified by the Office of Accounting is allowed and the placement type is non-contracted resource family home care/relative care, finalized subsidy adoption, or pending subsidy.
  - A rate of \$162.00 is required if the placement type is Related/Unrelated Para care.
  - A rate of \$250.00 is required if the placement type is Kinship Legal Guardianship initiated from **1/1/2002 through 6/30/2004**.
